





**THE AFTER-THE-FACT FEEDBACK THEOREM:** As non-believers in the **Pemerantzian "feedback"** postulate, we will take definite, perhaps controversial, positions on issues directly or indirectly affecting the students.

"Feedback" after an act is better than no "feedback" at all. <u>McGILL DAILY</u>: Retain political controversy (see "after-thefact feedback theorem" above).

SUMMER JOBS: We will attempt to obtain a greater portion of the "Opportunities for Youth" grants. But it is fraudulent and patronizing to promise a set number of jobs.

and patronizing to promise a set number of jobs. <u>RESEAU REPORT</u>: Work towards a student inter-university statement of opposition to the government's proposed centralizing policy.

Alternative to registration controls over professional faculties: Government should only provide a provincial career prognosis, thus influencing yet not restricting students' faculty choices.

Fierce opposition to government-proposed foreign student fee raise: Foreign students should not be made scapegoats for Quebec nationalism.

CAFETERIA: Maisonneuve's contract expires in July.

New negotiated contract must include a clause making ratification of Maisonneuve's services mandatory after every term. There are other caterers.

In the past, a student-run cafeteria has not proved feasible - financially or otherwise.

COMMUNITY McGILL: Review of club financing in order to give a greater share of funds to community involvements.

Stricter control on club expenditures - e.g. elimination of vague, "miscellaneous" headings.

■ BOOKSTORE METAMORPHOSIS: McGill Bookstore is changing location to the new Management building next January. A contest will be established to choose the best student brief on making the most advantageous use of the vacated space (examples: day-care

center, pub, coffee-house, whorehouse(!?) ).

#### STEPHEN LEOPOLD Candidate for President

Dear Fellow Student,

In the past year, the criminal code of Canada has been responsible for convicting over 10,000 persons on charges of possession or distribution of soft drugs (marijuana, hashish). That there has been no sustained and concerted public outcry of anger and protest over this statistic is a commentary on the lack of leadership that youth suffers. The present laws and penalties governing the use of soft drugs in Canada are, for want of a better word, obscene. They must be changed.

Ideas cause change. I believe it is now time to begin a campaign of protest against Canada's drug laws. Our aim will be to educate the public, and to pressure the government: to make them listen to what we have to say, to teach them what we know.

Voices cause ideas to be heard. I propose that the office of the President of the McGill Students' Society become a voice to help disseminate and direct the ideas of protest; that it be a centre for the proper conveyance of briefs, representations, and opinion surveys; and that it help to formally channel the articulate thoughts of today's youth to the attention of the public and the government.

Clearly, I am calling for a return to student activism. Canada's drug laws are oppresive, archaic, and stupid. They must be changed. We at McGill can be in the forefront of the fight to see that they are.



#### PRIORITIES

- 1. INTENSIFIED OPPOSITION TO FOREIGN STUDENT FEE INCREASE: The Students' Society, working with the I.S.A., will become an active instrument to DEFEAT the foreign student fee hike (from \$500 to \$2500). McGill must not become a cultural ghetto amongst world universities.
- 2. CAMPUS-WIDE CAFETERIA ALLIANCE: The food everywhere on campus is expensive, and plain lousy to boot. If all McGill cafeterias were to unite and negotiate contracts from strength, we would not then be fragmenting our power of the purse. Such an alliance would force the quality of the food to go up, and the price to go down.
- 3. <u>PUB IN THE UNION</u>: The bookstore is moving and the space is ideal for a student-run, student oriented pub. The idea has been researched and proven feasible. It deserves to be implemented.
- 4. RESEARCH THE FEASIBILITY OF ESTABLISHING A CAMPUS DAY CARE CENTRE.
- 5. <u>STUDENT REPRESENTATION</u>: Our representation on Senate is ineffective because of the consistently low <u>quality</u> of our representatives. In future, senators should be chosen through executive applications. Our ultimate influence on University policy is negligible because we have no representation on the Board of Governors. Pressure must be applied to attain seats on the Board.
- 6. BREAK-UP ARTS SCIENCE UNDERGRADUATE SOCIETY (A.S.U.S.): In the interest of attaining true representation by population, A.S.U.S. will be split up into 2 distinct undergraduate societies.
- 7. OPPORTUNITIES FOR YOUTH RESOURCES: Last year, McGill, with 9% of Quebec's university population, received only 2% of the monies allocated to the province through Ottawa's OFY program. The disparity is inexcusable; the situation will be reversed next summer through ADVANCE PREPARATION AND COMPRHENSIVE PLANNING.

- "Reseau Report": Oppose any future attempts by Government to centralize University education in Quebec. The quality of education is better when McGill has autonomy over its academic policies.
- Organize all student Senators into one united voice in Senate meetings.
- Study the feasability of establishing a unicameral tripartite governing body in McGill. (1/3 students, 1/3 faculty, 1/3 governors) This will eliminate a great deal of bureacracy that presently binds all Senate decisions.

Students' Council and the McGill administration and lecturers use bureaucratic rules and regulations in order to stifle student initiative, cut off debate and suppress the development of ideas. Aglaring case in point was the response of Students' Council hacks when faced with the constitution of the Academic Activities Committee nearly two weeks ago. Unable to present a coherent sentence to back up any of the objections they had to the name of the Committee, the Students' Council hacks threw a copy of Robert's Rules of Order at the audience, then used the rules to stop discussion.

Any initiative that comes from the Students' Council is stifled by the Students' Council in a bureaucracy of committees that do not develop open discussion. 3. OPPOSE THE USE OFMCGILL IN THE INTERESTS OF THE U.S. IMPERIALISTS AND THE ANGLO-CANADIAN COLONIALISTS:

McGill has always been a training ground in the interests of the colonizers of Quebec right from the days of James McGill. Today research and education are being carried out directly for these interests. Under the pretext of "academic freedom", courses are geared both in form and content to the passive acceptance of the "wisdom" of some "expert" lecturer (if he is there), while students are allowed to "question" the lecturer in order to merely clarify the "wisdom" that he(or she) is imparting. Under threats like "This is my course, take it or you fail", knowledge is not allowed to stand the test of the real world and some of the vilest anti-people theories are given in the classrooms, like:

\*"black people are innately aggressive due to inherent factors",

\* "underdeveloped countries don't know how to look after themselves, they lack \* "history is the history of the advance of the white race",

\* "colonisation is good because the uneducated colonised were inferior and similar to cows. Colonisation helped them to advance into the modern age", etc. These are some examples of racist and anti-communist theories perpetrated to promote contempt for the working and oppressed people in us, and to directly serve the interests of U.S. imperialism and Anglo-Canadian colonialism.

OPPOSE THE USE OF THE STUDENTS' COUNCIL AS A "JUNIOR PARTNER" of the Administration in supporting the status quo:

Students' Council bas always acted as an agent of the McGill administration. It uses to take any initiation to take even nominal stands unless pushed into it by refuses to take any initial students as in th- case of the Senate interference in the elections. Instead of acting as a student centre opposing colonialism, its hacks are busy lining up careers for themselves, and regularly come out with stands supporting the Anglo-Canadian colonial privileges of McGill. It tries to mask these activities by organizing diversions such as inane dances, rock festivals and erotic film shows. 4. SUPPORT, ENCOURAGE AND ORGANIZE PROGRAMS LIKE THE ACADEMIC ACTIVITIES COMMITTEE under the guideline "seek truch to serve the people".



In recent years, the Students' Society has divorced itself from the students. It has failed to keep abreast of changes in attitude undergone by the students. It is time for the Students' Society to reorient itself and begin a dialogue with the students. It must begin to face the issues, to discuss, and then act upon them.

In line with this, I support the platform of the Popular Student Front. I call for a change in the method of work, a change which will involve having the Student Executive becoming a part of the student body which elected them, instead of being bureaucratic elitists.

Some of the issues which I would personally like to discuss are:

Foreign Students Fee Hike: I support the Anti-Feehike Coalition, which is a grass root movement of students who seized the initiative in opposing the proposed fee hike.

Students and Quebec: We can no longer afford to ignore the political currents sweeping through Quebec. Among other things, we need to discuss the political and economic crisis, and how we can ally ourselves more closely with our people, the Quebec people.

Students and the University: We have had no real opportunity to participate in deciding the direction or orientation of McGill. We need to discuss McGill's role in Quebec as well as the question of the interests served by the university, among other things.

Students and the Classroom: We have been compelled to become 'note-takers' and 'fact memorizers' in the lecture room. We have no say in the orientation of courses. Do courses really serve our needs? Do we gain an understanding of the society and world in which we have to function? Or are these courses as irrelevant as many say they are? Discussions on these questions must be held, and action taken on the basis of the discussions.

#### **PROGRAM OF THE POPULAR** STUDENT FRONT

#### PSF RESOLVES THAT:

The present Students' Council bureaucrats do not serve the students but, in fact, serve themselves.

The Students ' Council uses a completely bureaucratic style of work, does not involve the students and is a privileged elite completely divorced from the large majority of students.

#### **PSF THEREFORE DECLARES THAT:**

Students' Council should lead the students, and not just follow. Council should deal with the real issues and involve students in its activities.

Students' Council should actively encourage, organize and support programs to foster a serious atmosphere of investigation and discussion on campus.

Students' Council must uphold the mass democratic method of work (as opposed to the bureaucratic, elitist method of work) which relies upon the students and is based on their needs and initiative.


