McGill Graduates Society of Vancouver and District


Sir Arthur Currie, L. L. D. Continued.

Dear Sir:-

I have the honour to acknowledge receipt of your letter of March 7th informing me as to the terms of a resolution which was passed on February 4th at a meeting of the McGill Graduate Society of Vancouver and district.

Yours is not the first resolution along these lines. From a number of graduates we have received similar resolutions asking us to preserve intact the class-room of Sir William Dawson when the Arts Building is altered. I cannot tell you what an embarrassing situation you are placing before us. To keep that room as it is now is to interfere with all the arrangements in the new Arts Building. It affects the level of floors, the arrangement of corridors and of class-rooms. The architects have, at the orders of the Board of Governors, given every attention and consideration to the preservation of this room as it is now. The firm of architects is Petherstonhaugh & McDougall, who are graduates of the University, and the consulting architect is Mr. Charles Saxe, whose brother is one of our most distinguished graduates. The advice of all of these architects is that the room cannot be preserved without forever making the Arts Building suffer from many of the inconveniences so apparent there now.

We are preserving the front wall of the Arts Building for the sake of tradition and no one appreciates the value of tradition more than I do. This wall will be absolutely useless for any other purpose.

Sir William Dawson's class-room is inconvenient, unsanitary, lighted from the wrong side, different level of floor at the back, and keeping it intact would, as I said above, interfere very greatly with the arrangement of the reconstructed building.

The Board of Governors would like to comply with the wishes of Graduate Societies in this regard, but they feel that such graduates as have asked for the preservation of this room have not considered the matter in all its bearings.

BANQUET TO GRADUATES OF MCGILL.

FRIDAY, April 2nd, 1880.

This social reunion was not intended to be public, but was merely a private entertainment given by the Principal, Dr. Dawson, on occasion of the 25th year of his term of office ; with the view, as stated in his card of invitation, of renewing old associations, of bringing before the members and friends of the University the results of their labours, of encouraging new efforts and securing more complete unity and co-operation. There are however some features of it in which the members of the University who were not so fortunate as to be present and the public generally may take an interest, and which do not fall within the request made that the proceedings should not be reported.

The invitations were of necessity limited to gentlemen on the lists of the University, and to a few representatives of other institutions of learning. Eight hundred and fifty cards of invitation were issued, beside those to the Graduating Class, about seventy in number. The result was that three hundred and sixty gentlemen sat down to a repast, provided by Mr. Alexander, at six long tables, filling the whole of the William Molson Hall, with the exception of a gallery prepared for ladies. The Hall had previously been decorated by the graduates and students for the Founder's Festival ; and these decorations, with some slight changes, remained, while the tables were liberally adorned with flowers. The guests assembled in the library, and were marshalled to the hall in order of University rank and of date of graduation, and when all were seated, the scene presented was one both novel and imposing.

Grace having been said by the Right Revd. Dr. Bond, the Bishop of Montreal, and sufficient time having been allowed for partaking of the refreshments furnished, and for conversation, Dr. Dawson addressed some words of welcome to his guests. The usual toasts were then duly honoured, including that of "the Lieutenant-Governor," who responded very cordially, and addresses were delivered

by representatives of the different bodies and interests connected with the University, and by representative of sister institutions. The topics were naturally those connected with the past history and present state of the University; and the part which its Governors, Principal and Fellows, its Benefactors and its Graduates, had taken in elevating it to its present condition, and in advancing the interests of Education. As to the future, the evening was signalised by the announcement of the intention of Peter Redpath, Esq., one of the governors, to erect a costly and capacious museum building on the College grounds, and that of the Principal to place therein as a gift to the University his own large geological collections, and the further announcement that the Graduates propose to commemorate the twenty-fifth year of the Principal's tenure of office by the creation of a University fund or the erection of a University building to bear his name.

The speakers on points more directly relating to McGill, were the Hon. Judge Day, Chancellor; Mr. P. Redpath, Hon. Judge Dunkin, Dr. E. T. Meredith, Dr. Campbell, Prof. Trenholme, Dr. Johnson, Prof. Bovey, Mr. R. A. Ramsay, Dr. Chamberlin, Hon. Dr. Church, and Hon. Mr. Lynch. The addresses of these gentlemen were replete with reminiscences of the olden time, new to many of the younger auditors, as well as with auguries and projects for the future.

Of the original Board of Governors, under the New Charter, only four members now survive. One of them, Mr. Davidson, has resigned his office, having removed to Scotland. The three others were present; namely, the Chancellor, Hon. Senator Ferrier, and Hon. Judge Dunkin. Of these the senior in appointment is Mr. Ferrier, who was a member of the Board of Royal Institution under the Old Charter, and is consequently the oldest member of the governing body of the University. Rev. Archdeacon Leach, the senior member of the corps of Instructors, was prevented by illness from being present.

Of the graduates present nearly one hundred came from different parts of Canada and the United States to be present at the entertainment, while hundreds of others, unable to leave their homes sent letters breathing a spirit of warm affection for their *alma mater*. Among those present there were many who have attained to high positions in public and professional life. The Lieutenant Governor, Dr. Robitaille, is a medical graduate of 1858. The Hon. Mr. Lynch, his Solicitor General, is a Bachelor of Civil Law and Gold Medallist of 1868. The Hon. Dr. Church, late Treasurer of the province, and President of the Graduates' Society, is a medical graduate of 1857. A large number of other names might be mentioned

of men who in public and professional life, as ministers of religion, members of Parliament and other public bodies, professors and lecturers in McGill College and other institutes of higher learning, eminent physicians and lawyers, workers in practical science and literature, have already made their mark and taken high positions. In looking around on the assemblage, and mentally noting what the men composing it are and have done, it was impossible not to be impressed with the evidence presented of the value and importance of the higher education; and this independently of what was spoken, was sufficient to give to the gathering a great value and significance.

Besides those more immediately connected with McGill, there were present the Rev. Dr. Cook, the Rev. Dr. MacVicar, the Rev. Dr. Wilkes, the Rev. Canon Henderson, as Principals of four of the Affiliated Colleges, on behalf of which Dr. Cook responded. The University of Bishop's College was represented by its Principal, the Rev. Dr. Lobley. Laval University was represented by the Hon. Dr. Chauveau; and the University of Toronto by Dr. Wilson. All of these gentlemen spoke in terms of friendly greeting on behalf of their respective universities.

The Visitor of the University sent the expression of his regret that he was unable to be present, and the Honourable the Superintendent of Education also intimated his good will and his regret that he was unable to attend.

Among the older and more eminent graduates who were unable to attend and sent cordial letters of apology, were Dr. Workman, of Toronto, a medical graduate of 1835; the Honorable Alexander Morris, a graduate in arts of 1849, and formerly one of the governors of the College; the Honorable J. J. C. Abbott and the Rev. Dr. Douglas.

It was stated that the session of 1882'3 will be the fiftieth year of the existence of McGill University, and it is proposed to celebrate this anniversary, and to prepare in connection with it a sketch of the history of the College, for circulation among its friends and graduates.

The evening was enlivened with college songs admirably sung by a choir of graduates. Two of the songs were original compositions; and through the kindness of Mr. G. B. Burland, copies printed on elegantly illuminated cards were supplied to all the guests.

TO ALL GRADUATES AND FORMER STUDENTS OF MCGILL

With this letter the Graduates' Society of McGill University sends to you a copy of its new Constitution and By-Laws. You are asked to read them and consider them carefully. You are asked to be an active member in the Graduates' Society of your University.

GRADUATES'
SOCIETY
RE-ORGANIZED

Not long before the war, the Graduates' Society was reorganized. The war interrupted the programme then commenced.

When war began, the Graduates' Society sought, and received, permission from the Dominion Government to organize means by which students, graduates and members of the University, might be enabled to serve to the best advantage. Authorization was secured for a McGill Battalion of the Canadian Officers' Training Corps. The graduates and undergraduates through their respective societies invited the Right Hon. Sir Auckland Geddes, K.C.B., (now Minister of Reconstruction in the British Cabinet), who was then Professor of Anatomy at McGill, to take command of the C.O.T.C. Much of its success was due to him. All who worked with him are glad that he is returning to McGill as Principal. Through the opportunities offered by McGill's C.O.T.C., 1,400 men, from all the Universities and High Schools of Canada, went overseas with the University Reinforcing Companies. Most of them served with Princess Patricia's Canadian Light Infantry. Many of them became officers.

Several units were more directly identified with McGill. The regimental badge of the 148th Battalion is the McGill Crest. This Battalion was officially affiliated with the University. Many men in the ranks and 75% of its officers were McGill men. Teachers, graduates and undergraduates were all enrolled. "No. 3 Canadian General Hospital (McGill)" is the authorized title of the Hospital organized by the Faculty of Medicine. The Faculty supplied all of the officers and many of the men.

THE GRADUATES' SOCIETY OF MCGILL UNIVERSITY

The 7th Canadian Siege Battery (McGill) and the 13th Canadian Siege Battery (McGill) were both organized in the University, as was the 2nd Canadian Divisional Sanitary Section.

In addition, the University played an active part in the military life of Montreal. It gave preliminary training to many. The buildings and the campus were in constant use for instruction and drilling; for four years no grass grew on the campus. The Graduates' Society, individually and collectively, was a part of these things.

With the assistance of the Society, substantial regimental funds were provided for all the McGill units. The Graduates' Society also collected from past students of the University, \$2,800 for the Canadian Patriotic Fund.

McGill men served in many ways and in many units other than those which were associated with the University. Their record of war service is a proud one.

In August, 1914, McGill had 284 persons on the staff of the University, 6,000 past students and 2,104 students. In November, 1918, 90 members of the staff, 1,673 past students and 756 students had enlisted. Of them, 320 had died and 873 had been wounded. They had won four hundred and forty British decorations, and, twice, the Victoria Cross.

During the war, McGill men served with the Imperial and Canadian navies and filled many important civilian posts both in Canada and overseas.

Now that the war is over, the Society is taking up where it left off when war began. For success, the Graduates' Society needs the interest and membership of every one who studied at McGill.

The following paragraphs outline the programme of the Society:

PROGRAMME

I. *The Stadium.*—McGill has suffered for lack of students' residences, a gymnasium and playing fields. In 1911, Sir William Macdonald gave a magnificent property of thirty acres for these purposes. Macdonald Park, as it is called, lies at the foot of Mount Royal, just to the north of the new Medical Building.

With the approval of the Graduates' Society, fifteen men united in a Graduates' Stadium Committee. The Committee was formed to build an athletic field, a quarter mile track and a concrete grandstand seating 10,000. These things have been done. The Stadium is completed. During the war it was used for military purposes. Inter-collegiate football will be played there this autumn. The Chairman of the Stadium Committee was Captain Percival Molson, killed in action near Lens. Three other members of the Committee, Guy Drummond, John McCrae and William Stewart died in the war; and all, who were recent graduates, were in uniform.

One of the members of the Committee, a past president of the Graduates' Society and a governor of the University, Commander J. K. L. Ross, has generously undertaken the construction of the gymnasium building, including drill-hall and swimming pool, which is to form the entrance to the Stadium.

THE GRADUATES' SOCIETY OF MCGILL UNIVERSITY.

The Graduates' Stadium Committee made themselves responsible for the interest on an expenditure amounting to \$140,000. By his will, Captain Molson left \$75,000 for the Stadium. It is expected that the income derived from the Stadium will defray the remaining cost of its construction. It is managed by a committee of students and of graduates.

II. *"The McGill News."*—In 1914, the Society distributed issues of the "*McGill Daily*" to its members. These issues were specially prepared for the graduates. In future, it is intended to issue a quarterly publication. It will be sent without charge to every regular member of the Society. Its purpose will be to maintain touch among the graduates and between them and their University. It will be managed by graduates who as students made a permanent success of the "*McGill Daily*"—the only college daily newspaper in Canada.

III. *The Reunion.*—The Society had intended to hold a Reunion of McGill's Old Students in 1915, at the opening of the Stadium. The war intervened. Now, a reunion of all McGill men, at the University in Montreal, is planned for the autumn of 1921. A committee of organization is already at work under Brig.-General G. E. McCuaig, C.M.G., D.S.O., (Sci. '06).

IV. *The Election of Graduates' Governors.*—In the direction of the University's affairs, final decisions lie with a board of twenty-five governors. Eight of them are graduates of McGill. In order that past students may have a more directly responsible interest in the well-being of the University, it is expected that the Governors will permit at least three of their number to be elected by the members of the Graduates' Society. These, the Graduates' Governors, will be elected for a term of six years by the mailed vote of all members of the Society. One will be elected every second year.

V. *Social Service.*—Following the example of many British Universities and of an even greater number of American Universities, and of the University of Toronto, McGill has developed a training school for social workers under its Department of Social Service. For this work the Graduates' Society has pledged itself to contribute \$1,000 a year for three years, beginning in 1918.

VI. *Other Activities.*—The Society hopes to arrange for the maintenance of an Appointments Bureau, through which employment will be obtainable by McGill men, and of a Students' Assistance Fund, through which loans will be made in suitable cases, to students who need money in order to complete their courses.

VII. *The University.*—A modern University can do sound work only when it has instant and accurate touch with the life of the community which it serves. A University can be kept in understanding with a community only through the experience of graduates who share in that community's life and work.

With their experiences, graduates can repay part of the debt owed by them to the University that taught them. We, literally, owe a debt to our Alma Mater for our teaching, because the cost of the equipment and instruction which

McGill provides for her students is far from being borne by those students' fees. Graduates usually recognize that debt. Graduates can repay it in many ways. They do so, by pointing out opportunities for new developments and for improvement in the University's work. They do so, by telling those who seek instruction of the opportunities for graduate and undergraduate study which their University offers. They do so, not only by generous gifts from themselves but, by directing to their University benefactions from those who are about to give for public uses. These are services owed to McGill by each of her children.

Dear Mr. Jeakins:-

I have just received your letter of January 19th making inquiry with reference to "Student Advisers".

I inaugurated the system of "Student Advisers" in the Faculty of Applied Science some years ago. It has proved to be of great value and is now in full operation.

Dean Moyses introduced the same system into the Faculty of Arts shortly after. I believe it is working very well there. You might consult him with reference to it, as it has been developed in that Faculty.

With reference to the question as to whether this system could be introduced with advantage into the Faculties of Law and Medicine, I would suggest that you consult the Deans of these Faculties. Until the present year the enrolment in the Faculty of Law has been comparatively small and, probably, the Dean of that Faculty has acted more or less in the capacity of an "Adviser" to the various students of the Faculty. Many of these men have already graduated from the Faculty of Arts and have, therefore, not the same need of an "Adviser" as men who are coming to the University for the first time.

I may say that in the Faculty of Applied Science the "Advisers" are appointed only to the men of the First Year; seeing that by the completion of that year, the student has become acquainted with the conditions in the University and City, so that he is not in the same immediate need of an "Adviser" as when he first came to the University.

In the Faculty of Medicine, where the enrolment is very large and the men, for the most part, matriculate directly into this Faculty, I should suppose

that it would be of advantage to the men of the first year to have an "Adviser" to whom they may always go for direction and assistance. Dean Birkett, however, will be able to advise you on this matter.

You will understand that both in the Faculty of Arts and in the Faculty of Applied Science, the Professors are not obliged to act as "Advisers", but with them, the assumption of this position is purely voluntary.


Dear Dr. Adams :-



To Graduates and past Students of McGill:

The McGill Reunion Committee presents for your information the following facts regarding the Centenary Reunion:

DATE

1921—October 12th, 13th, 14th and 15th.* These are the dates decided on for the McGill Centenary Reunion, shortly after the opening of the fall session and during the football season.

ATTENDANCE

From reports received to date from the various district secretaries, an attendance of about four thousand old McGill students is expected at this—the first general Reunion. As the total number of living graduates is about six thousand, everyone will meet many class-mates.

TRANSPORTATION

The committee in charge of transportation has arranged with the Association of Railway Passenger Agents to secure special rates, and it is therefore essential that you inform the secretary of your district and the general secretary whether you hope to be present. I have, this morning, received your favour of the 7th instant and very much regret the misunderstanding that has arisen.



It is agreed between the sender of the message on the face of this form and this Company, that said Company shall not be liable for damages arising from failure to transmit or deliver, or for any error in the transmission or delivery of any unrepeatable telegram, whether happening from negligence of its servants or otherwise, or for delays from interruptions in the working of its lines, for errors in cypher or obscure messages, or for errors from illegible writing, beyond the amount received for sending the same.

To guard against errors, the Company will repeat back any telegram for an extra payment of one-half the regular rate, and in that case the Company shall be liable for damages, suffered by the sender to an extent not exceeding \$200., due to the negligence of the Company in the transmission or delivery of the telegram.

Correctness in the transmission of messages can be insured by contract in writing, stating agreed amount of risk, and payment of premium thereon at the following rates, in addition to the usual charge for repeated messages, viz: one per cent. for any distance not exceeding 1,000 miles, and two per cent. for any greater distance.
