
Dear Sir Arthur:-


Dear Sir Arthur:

Dear Ruttan:-

Is your resignation from the executive committee of the Biological Board final? If so, I shall regret it very much, not only from the fact that you represent the chemical interests upon the committee, but also on account of the loss of your advice in matters of general policy.

If you are determined upon this step, does it also imply resignation as a member of the Board, and if so, have any steps been taken to appoint somebody to represent McGill in your place? The appointment is made by the University and sent to the Minister for approval, and it seems advisable that steps in this direction should be taken as soon as possible, if they have not already been considered.

As Canon Huard has also resigned from the executive, the number on that committee is very much reduced and it is advisable that we should take steps to bring it back to its original number.

Dear Dr. Adams:

You are no doubt aware that a representative of McGill University has always been a member of the Biological Board of Canada, and that position has been held by the following McGill Professors, viz:- the late Prof. Penhallow, Prof. MacBride, Prof. Willey and Prof. Adami.

Prof. Willey retired because he wished to undertake an important piece of work for which the Board felt bound to pay an Honorarium, and the Act of Parliament does not permit a member of the Board to receive any such payment. Prof. Adami therefore consented to replace Prof. Willey; but as he has left Canada permanently, it will be necessary to appoint a new representative. There is no hurry in the matter, because the Board asked Prof. Willey to act as representative pro tem. In view, however, of the fact that Chemistry is now of such high importance in all Biological Researches, I have felt, as Chairman of the Board,

that we ought to have an eminent chemist, and I should feel that the Board would be greatly strengthened if Prof. Ruttan could be appointed. Prof. Ruttan would be able to assist greatly in such questions as the utilization of fish waste, production of fish oil, etc., which are problems which the Board have already been handling. Of course, I merely make this suggestion, and it may not approve itself to you, but in Dr. Willey we have a fine representative of biology, and even though he is not technically a member of the Board, his close association with us in the researches carried on under the Board in Pacific and Atlantic waters gives us all the advantage of such a biological representative from McGill.

Of course you are no doubt aware that each of the universities named on the cover of the report which I now mail to you, has nominated its representative, and there are two, myself and another, nominated by the Minister to represent the Naval Department. I shall be glad to hear from you on this matter.
