The Summer Vacation School has been arranged to provide an intensive course for those in charge of Rural Library Systems (under the Public Libraries Act of 1919). This will comprise 40 Lectures, illustrated by demonstrations, visits to Libraries, etc. The 10 lectures by the Director dealing with recent English writers will be useful also to Teachers, Conductors of Reading Circles, etc.

Worcester and the neighbourhood are rich in architectural, historical and antiquarian interest, and in natural scenery. Visits will be made under expert guidance to the Cathedral and other buildings, and evening and Saturday excursions are being planned to Malvern Priory and the Malvern Hills, Stratford-on-Avon, Tewkesbury, Hereford, Evesham, and the Oxford Colleges and Libraries.

A Public Inaugural Meeting will be held at the Guildhall at 6 p.m. on Monday, August 22nd, at which the Mayor of Worcester, Alderman Charles Edwards, and the Very Reverend the Dean of Worcester, Dr. Moore Ede, will receive the Students, and an account of the Rural Library Schemes will be given by Lt.-Col. J. M. Mitchell, O.B.E., M.C., B.A., Secretary of the Carnegie United Kingdom Trust.

Fee for the Course £2 2s. Od. (£1 1s. Od. for students of the School of Librarianship).

Students will be responsible for making their own arrangements for residence in Worcester, but, for the convenience of students, the Local Secretary, Mrs. L. M. Marshall, of 25, Penbury Street, Worcester, has kindly undertaken to advise them, and has prepared a list of available apartments at charges varying from £2 to £2 10s. a week for board and lodging.
