WE COMMAND you to summon

*The Sun Light Gas Company Limited, a bona fide public & corporate body duly incorporated & having its head office & principal place of business in the City & District of Montreal, P. Q. Canada, at the House of La Roche said District & St. J. South of the City & District of Montreal*
