Know all men by these presents that I
Saisa Mackenzie of the Parish of Stth Mary's in
the Province of Upper Canada have made
deputed constituted and appointed & in my
place & stead put, and by these presents
do make depute constitute and appoint
& in my place and stead put the Honorable
Roderick Mackenzie of the Parish of
Terrehoume, in the Province of Lower
Canada, my true and lawful attorney
for me & in my name to act in and
conduct & manage all & every the affairs
matters & things of me the said Saisa
Mackenzie being or happening within the
said Province of Lower Canada in
my absence; and for me & in my
name to demand levy and recover
from all whom it doth or may concern all
such sum or sums of money goods & things
whatsoever as are now due & which may
or shall grow due payable or belonging to
me by any ways or means whatsoever or
whatsoever: and more particularly for me
and in my name to demand recover
and receive from George Moffatt Esquire
of Montreal in the said Province of Lower
Canada, Merchant, in his capacity of Curator
duly appointed to the Estate & Succession of
the late Kenneth Mackenzie Esquire in
his life time of the Indian Territory all
such sum or sums of money whatsoever
as are now due and which may or
shall grow due payable or belonging to me,
by, from or in respect of a certain annuity
bequeathed

bequeathed to me by the said Kenneth Mackenzie
by his last will and testament bearing date at
Fort William on Lake Superior the fifteenth
day of August in the year 1816 or any arrears
of the said annuity. And upon receipt of
such sum or sums of money or of such arrears
or any part thereof, acquittances or any
other sufficient discharges for the same for me
and in my name to make seal and
delivered - And also for me and in my
name to settle any outstanding account or
accounts or reckonings or reckonings whatsoever
wherein I the said Louise Mackenzie now
am or at any time or times hereafter shall or
may be in any wise interested or concerned
with any person or persons whomsoever and
particularly with the said George Moffatt
in his said capacity of and concerning the
said annuity and any arrears thereof and
to pay and receive, claim & recover the
Balance or Balances thereof as the case may
required - And also for me and in
my name as aforesaid to appear and my
person to represent in all or any Court or
Courts and before all or any officers of or in
Law or Equity whatsoever, as by my said
Attorney, shall be thought advisable or as he
shall think fit - & to sue, arrest, distrain
upon, imprison and out of prison again
to liberate release acquit and discharge
all & every or any person or persons whom-
soever now indebted or who shall or may
at any time hereafter become indebted to
me or upon whom I now have or hereafter
shall

shall or may, have any lawful claim or demand - And also for me and in my name as aforesaid or otherwise to commence any action or actions, suit or suits as well real as personal or mixed in any Court of Law or Equity, for the recovery of any debt, sum or sums of money, right, title, interest, property matter or thing whatsoever, now due or payable or in any wise belonging to me by any means or on any account whatsoever, and the same action or actions, suit or suits to prosecute and follow or to discontinue and become non-suit therein if he my said attorney shall see cause; and also for me and in my name to use and take such other lawful ways & means for the recovering, receiving, obtaining or getting in any such sum and sums of money or other things whatsoever, which is, are, shall or may be or by my said attorney shall be conceived or thought to be due, owing, belonging or payable unto me by any person or persons whomsoever; and also to appoint any attorney or Attorneys or Solicitor or Solicitors at Law or in Equity and to give and sign any warrant or warrants to prosecute and defend in the premises aforesaid or any of them as occasion may require either in my name or in the name of him my said attorney - And generally to do all and every or any other acts, deeds, matters and things whatsoever in and about the premises as amply & effectually to all intents and purposes as I could do or have done in my own proper person if these presents had not been made - I hereby revoking all

other or former letters or powers of attorney by
me heretofore given for the purposes aforesaid
said or any other purpose whatsoever; and
I the ^{Said} Louisa MacKenzie hereby ratifying and
confirming and promising and agreeing at all or
any time or times to allow, ratify and confirm
all and whatsoever my said attorney the
said Honorable Rodrick MacKenzie shall
lawfully do or cause to be done in and about
the premises aforesaid by virtue hereof. —
