

To the Shareholders:

Your Directors submit herewith the Company's Income Account and Balance Sheet as at 31st December 1933.

Construction in Canada during the past year was at its lowest since 1919 and consequently the business of your Company suffered. Substantial reductions were made in expenses during the year but, after charging the usual rates of depreciation, the result in the year's operations was a loss of \$104,659.29; this compares with a loss of \$177,340.18 in 1932.

We again wish to call your attention to the cash position of your Company, current assets and investments being 28 times current liabilities. Your Company is in a position to avail itself of any increase in business should general conditions prove more favorable during the coming months.

During 1933 your Company purchased 237 shares of preferred stock for redemption and cancellation, this resulting in a capital surplus of \$9,704.02.

It is with sincere regret that your Directors record the death of Mr. Charles Duncan who has been associated with your Company for some years. The vacancy created by his death has been filled by the election of Mr. L. A. Johnson to your Board.

Meetings of your Board of Directors have been held monthly, the books of your Company have been audited regularly and the certificate of the Auditors appears in the financial statement herewith submitted.

Your Directors wish to record their appreciation of the loyal and efficient service of the staff during the year.
