## TABLE OF SIGNS.

Visiting List.—The form is taken from the Physician's Visiting List. Each patient has a line, and each day in the year a column.

The following are the necessary signs to be placed opposite the name under the column for the day :

- Visit to be made.
- i* Second Visit to be made.
- IO* Visit to be made at a certain hour.
- C* Consultation.
- L* Visit made and Medicine sent.
- O* Obstetric Case.
- /* Visit made.
- X* Second Visit made.
- N* Night Visit.
- CE* Consultation held.
- V* Vaccination.
- 6* Office Advice.

Medical Record.—Under the head of TERMINATION, place "Recovery," "Death," "Better," or "Stationary," as the case may be. Under REMARKS, place any important facts, whether connected with character of disease, (as typhoid, grave, trivial,) or treatment, (as tonic, depleting,) or locality, (as malarial.)

Obstetrical Record.—Under the head of PRESENTATIONS, use the following abbreviations :

FOR THE VERTEX—Left Occipito—Iliac, L. O. I.  
 Right " " R. O. I.  
 Occipito—Public, O. P.  
 Occipito—Sacral, O. S.

FACE to the Right Side, F. R.  
 " " Left " F. L.

SHOULDER—Right Shoulder, Back Anterior, R. S. B. A.  
 Left " " " L. S. B. A.  
 Right " " Posterior, R. S. B. P.  
 Left " " " L. S. B. P.

PELVIS—Back to the Left P. B. L.

PREFACE.

SEVERAL years' experience in the publication of the "PHYSICIAN'S DIARY," has convinced the compiler that the success of the enterprise cannot be increased by the addition of any considerable amount of Reading matter. The utility of such a *Vade Mecum* depends mostly on the convenience of its size. Its objects are to enable the Physician to maintain punctuality in his appointments, accuracy in his accounts, and fidelity in his record of disease. These should not be sacrificed in an attempt to embody in a Pocket Book a compound of practice. Accordingly, the compiler has introduced no extraneous matter to increase the bulk of a book, and has adhered to that simple and convenient arrangement which has hitherto won the favor of the medical public.

## Proportionate Doses for Children.

FOR children under ten years, add twelve to the age and divide by the age ; thus, at three years, the dose will be one-fifth that for adults, viz :

$$\frac{3-1-5=}{3-1-5=} \qquad \frac{1}{5}$$

Castor Oil and Calomel require larger proportionate doses.

Opium requires smaller doses ; other exceptions exist, but the rule is good in all ordinary cases.

## Poisons.

IN all cases of poisoning, evacuate the stomach, either by the active emetics, such as sulphate of zinc, or by the stomach pump. Maintain the vomiting, when produced, by mustard, titillation of the fauces, and warm drinks.

Poisons.	Antidotes.
<i>Acids.</i>	THE ALKALIES.—Soap suds, lime, water, chalk, magnesia, soda, saleratus.
<i>Caustic Alkalies.</i>	THE ACIDS.—(Vegetable), vinegar, also oils.
<i>Baryta or Lime.</i>	Epsom or Glauber salts, oils.
<i>Iodine.</i>	Starch.
<i>Iodine of Potassium.</i>	No antidote ; rely on vomiting.
<i>Antimony.</i>	Astringent infusions, oak bark, galls, tannin.
<i>Arsenic and compounds.</i>	Hydrated peroxide of iron in tablespoonful doses, every 5 to 10 minutes. Also, magnesia in large doses.
<i>Bismuth and compounds.</i>	Albumen, sweet milk, mucilages.
<i>Copper and compounds.</i>	Strong coffee, albumen, mucilages.
<i>Gold and its salts.</i>	Sulphate of iron, mucilages.
<i>Iron and its salts.</i>	Carbonate of soda.

Place the patient in a diagonally recumbent position upon his side and belly, the head depending; imitate the motion of respiration by alternately compressing and expanding the ribs and abdomen. Apply warmth and friction to the extremities, and irritate the larynx by the fingers applied through the mouth.
